6. Accidental release measures

Keep combustibles (wood, paper, oil, etc.) away from spilled material. Cover with plastic sheet to prevent spreading. Absorb in vermiculite, dry sand or earth and place into containers. Following product recovery, flush area with water.

7. Handling and storage

Precautions for safe handling

Do not allow backfeed into the container. Purge air from system before introducing gas. Use only properly specified equipment which is suitable for this product, its supply pressure and temperature. Contact your gas supplier if in doubt. Do not re-use empty containers. Avoid contact with eyes. Use only in well-ventilated areas. Wear appropriate personal protective equipment.
